Workers' Compensation Board FEE VALUE CHANGES:

Read WCB's statement to physicians: Physician compensation continues at WCB (July 16/25)

WCB MEDICAL SERVICE UNIT

Effective August 27, 2025, the Workers Compensation Board Medical Service Unit (WCB MSU) value has been restored to the same rates as MSI. Therefore, the WCB MSU will be \$2.90, and the WCB AU will be \$27.38.
